BE IT RESOLVED that the Center Township Trustee, pursuant to I.C. § 36-6-4-8(b), desires to assist the Hilltop Food Pantry, an Indiana not for profit corporation organized under the laws of the State of Indiana to further their goal of providing resources, support and advocacy to food insecure individuals.

BE IT FURTHER RESOLVED, that the Township Legislative Body, at a properly noticed public meeting consented to an appropriation of Five hundred dollars (\$500.00) per month or six-thousand dollars (\$6,000.00) per year to support the Hilltop Food Pantry's mission.

BE IT FURTHER RESOLVED, that the appropriated funds shall not be disbursed until such time as services have been rendered by the Hilltop Pantry and a proper claim submitted for those services to the Office of the Center Township Trustee for review and approval.
